1 Welcome by the National President

3 Minutes of the 2018 Annual General Meeting

4 2018 Annual report and financial report

P Calvert outlined the major achievements of the APA for the year as follows

- Notable wins in the Advocacy area including, Private Practice funding and the hourly rate applicable under the NDIS
- Acknowledgement of the number one physiotherapy journal in the world the Journal of Physiotherapy
- Closer relationships established with the medical professions of Australia
- Relationships strengthened with Federal politicians including Ministers Hunt and King and Senators Di Natale, Wyatt and Mckenzie
- Very successful APA Conference held in Hobart

- Continual work in the establishment of Career pathways for physiotherapists
- Establishment of a new CRM member database
- Strengthening of APA financial reserves

He thanked the executive team, led by the CEO, C Massis, and the staff of the APA for their excellent efforts over the last 12 months.

C Massis outlined the financial results for 2018 and informed the meeting of the following key factors:

- Strong surplus recorded that enables the APA to continue its current path and to have the ability to act on unforeseen circumstances should they arise
- Revenue segregation explained with a strong focus on the continued growth of non-member revenues
- Expenditure breakdown for the year was noted with the realisation that greater expenditure levels in advocacy and marketing will likely eventuate in upcoming years

Attendees were asked for any questions that they might have.

A member asked what we were currently doing in the NDIS area. The CEO noted that we are working closely with the NDIS but that we need to do further work on the financial modelling of a practice

A question was asked as to whether we have an ideal amount set for future advocacy and marketing expenditure. It was explained that there is no set defined number but that the APA has recognised it must increase expenditure in this area.
