Developing news

Aged care COVID-19 measures a good move but more needs to be done

The APA welcomes the new temporary funding measures announced in response to the Royal Commission's Inquiry into the Impacts of COVID-19 on Aged Care.

The doubling of the number of allied health sessions available under Chronic Disease Management Plans (CDMs), from five to 10 consultations, will better address the complexities of treating older people in residential aged care facilities.

The APA has long called for the number of physiotherapy sessions available to older people under CDMs to be increased. Five sessions to meet all the allied health needs of a chronically ill or physically deconditioned person has never been enough to provide comprehensive care.

The introduction of group allied health sessions in homes where there have been COVID-19 outbreaks or periods of extended lockdown will also have an enormous impact on the well-being and independence of residents.

The APA is calling for these new measures to be made ongoing and available to all older Australians.

The APA will continue to advocate strongly for improved access to ongoing and episodic restorative and reablement care in the aged care sector.

The association is waiting on the outcomes of Royal Commission into Aged Care Quality and Safety's final Report next year – and expects to see the Government embrace substantial funding reform.

Release of Overcoming Indigenous Disadvantage report

The 2020 Overcoming Indigenous Disadvantage (OID) has been released. The OID provides a comprehensive report measures the wellbeing of Aboriginal and Torres Strait Islander people.

This year's report has shown mixed outcomes with improvements in early childhood development and economic participation. However, outcomes related to obesity and nutrition, access to primary health care, mental health and self-harm are concerning.

In addition to providing a snapshot of Aboriginal and Torres Strait Islander wellbeing the report also demonstrates the barriers to positive change want is required to overcome this. Key to seeing positive outcomes is shard decision making between Aboriginal and Torres Strait Islander communities and governments.

Latest advocacy and emerging issues

Aged care

The APA has publicly responded to a Federal Government's response to the Royal Commission Inquiry into the Impacts of COVID-19 in Aged Care.

The government announce it had accepted and acted on all recommendations with a \$132.2 package of measures. These include:

- \$12.1 million for additional individual allied health sessions under Medicare chronic disease management plans. There will be 10 allied health consultations available under the plans, up for 5.
- \$15.7 million for allied health group services for residents living in facilities affected by COVID-19 outbreaks. These funds will be distributed via PHNs in regions affected by COVID outbreaks in aged care facilities. The APA will advocate for physiotherapy group sessions directly with PHNs.

While these measures are positive step, the APA will continue to advocate for them to be made permanent and for significant funding reform in the sector.

The Aged Care Quality and Safety Commission has released a new resource on Outbreak management planning in aged care. Compensables

New South Wales

The APA has further met with SIRA this week to provide verbal feedback from the recent member consultation regards the possible fee schedule changes.

The APA is presently finalising a formal written submission to SIRA. The key messages that will be relayed will include:

- establishment of a pro-rata Consult C code for a defined cohort of workers
- establishment of safeguards to ensure physiotherapists are appropriately remunerated for the essential 'value added' roles undertaken outside of the consult such as verbal and written liaison, report writing, completion of fax requests, etc
- maintenance of the home visit item codes for a defined cohort of workers

The APA had additionally highlighted the Increasing inequality between the rate that physios are being reimbursed for work cover patients when compared to private/commercial based clients, which will likely be a mounting deterrent for experienced, competent and busy providers to remain involved in the scheme.

SIRA are asking for feedback from physiotherapists who provide services to people injured at work and who are an important part of the care framework delivering optimal health, recovery and quality of life outcomes to compensation scheme participants.



The Monash University evaluation of the role physiotherapists have played in the NSW scheme introduction of certification is also open. The APA strongly encourages that uptake of the survey to help Monash with the evaluation of this important role for physiotherapists in the NSW scheme. The survey is pertinent to all physiotherapists, whether you have issued a certificate or not.


Victoria

COVID-19

The APA and AHPA have strongly advocated on behalf of the physiotherapy profession and allied health to ensure continuity of safe practice via telehealth and face-to-face care since the onset of COVID-19. We are in regular contact with State Chief Allied Health Officers, the Minister for Health and relevant departments.





While it is pleasing we are moving to a "new normal" across the country, we are working hard to keep members updated as changes occur.

South Australia

From 1 December 2020, physiotherapy practices in South Australia:

- Will be required to have a <u>COVID-Safe</u> <u>Plan</u>.
- The COVID-Safe Plan for healthcare settings must include a contact tracing system, such as the COVID-SAfe Check in.
- <u>All people</u>, including patients, patient's family members, healthcare staff, administrative staff, contractors and cleaning staff, are required to wear <u>single</u> <u>use surgical masks</u> when on healthcare sites. Cloth sites are not sufficient for healthcare settings.
- Exemption to mask wearing includes certain breathing difficulties, mental health conditions, communication with those hard of hearing and those under the age of 12.
- Density requirements should be 1 person per 4 square meters. Density requirements do not include people employed at the practice.

New South Wales

It is now a requirement for practices to record the details of patients and staff coming into the practice which should be done electronically, such as QR code or spreadsheet.

Department of Veterans' Affairs

The Department of Veterans' Affairs (DVA) has revised its Rehabilitation Appliances Program (RAP) National Schedule of Equipment.

Changes include:

- indexation of prior approval financial limits, effective 1 November 2020
- references to the new Assistive Listening Devices form
- changes to a full prior approval required for some prosthetic items and TV connected video magnifier.

Treatment Cycle Review

In October 2019 the Department of Veterans' Affairs (DVA) introduced treatment cycle arrangements for referrals from general practitioners to allied health providers. The arrangements are currently being independently evaluated by the Queensland University of Technology (QUT) at the request of DVA.

QUT is seeking input from as many individual providers as possible. If you would like to take part, you can complete an online survey at <u>www.qut-dva-treatmentcycles-</u><u>evaluation.com</u>.

It will take about 10 minutes to complete. After completing the survey, participants will be invited to nominate to participate in a follow-up interview to discuss their opinions and experiences.

Digital health

The APA were represented at the AHPA secure messaging forum with the following were the intended aims of the workshop:

- understand the potential role of secure messaging in clinical workflows and
- to identify barriers and opportunities related to using secure messaging



The workshop focused on:

- enabling mapping of typical communication/information pathways occurring in practice now
- which pathways may or may not be appropriate to use secure messaging
- whether you have considered using or do use secure messaging, and if so
 - o which system/s?
 - o what has stopped you using them?
 - o what opportunities has using them created for you?

Private Health Insurance

Bupa has announced its support of the Commonwealth's decision to support telehealth ongoing for Allied Health.
