

Component I. Evidence ('Show') Portfolio'

Demonstrate competence against the **Titling Evidence Portfolio Pathway OHP Learning Outcomes** aligned to the 7 roles of the <u>Physiotherapy Competence Framework at Milestone 3</u>

Refer to the Guidelines for OHP Titling Evidence Portfolio Pathway Information Handbook

Submitted evidence must have been undertaken/completed within the last 10 years

PRACTITIONER

Submission Demonstration of evidence for the Practitioner role is via submission of the Analytical Review submission)

Examples of other supporting evidence* may include (as appendices):

- · a literature review
- report
- video
- media activity (radio interview, article in the press)
- training session
- accident investigation
- rehabilitation/return to work of an injured worker
- on-site physiotherapy practice, prevention activities, policy development, health promotion activity.

COMMUNICATOR

Accepted supporting evidence includes:

- As above for Practitioner role
- Examples of referral letters/letters to referring practitioner/client (de-identified)
- Examples of worker/client records (redacted to meet privacy requirements)
- Attendance at appropriate communication course
- Cross reference to Overall Critical Reflection template (Component III) and Cultural Capability Reflection (Component II)

COLLABORATOR

Accepted supporting evidence includes:

- As above for Practitioner role
- Documentation of collaboration: Provide evidence of collaborative efforts within professional or industry bodies including:
 - Negotiating overlapping and shared responsibilities with other health professionals
 - Strategies to promote understanding, managing differences and/or resolving conflict
 - Safe transfer of care to another health professional, setting or stage of care
- Cross reference to Overall Critical Reflection template (Component III) and Cultural Capability Reflection (Component II)

LEADER

Accepted supporting evidence includes:

- Mentorship and support: Showcase involvement in mentoring or supporting colleagues
- Membership engagement: Demonstrate participation and contributions to relevant professional boards or committees
- APA Course: "The art of communication in leadership to create an inspiring culture" with reflection
- Evidence of any other leadership course/workshop attended relevant to practice (to support evidence if needed) and reflection on learning during course and application to practice

HEALTH ADVOCATE

Accepted supporting evidence includes:

- Identifying and addressing determinants of health with worker/client (addressed in OHP case studies)
- Incorporating illness and injury prevention, health promotion and/or health surveillance activities into practice (addressed in OHP case studies)
- Contribution to improvement of health in the community
- Health Advocate Vignette: Collaborating with patients to recognise and tackle health determinants, clients
 adopting healthy behaviours, health prevention, integrating preventative measures, promoting health, and
 contributing to community health enhancement.
- Cross reference to Overall Critical Reflection template (Component III) and Cultural Capability Reflection (Component II)





SCHOLAR

Accepted supporting evidence includes:

- a literature review
- refereed journal article
- published book (sole author, joint author or contributor)
- research activity
- review of statistics/data/other sources of OHS information
- audit of OHS management systems
- Review of screening tools and their limitations
- Research contributions: audits, systematic reviews and/or involvement in research projects
- Evidence based practice in the treatment and management plans
- Evidence of Professional Development
- Evidence of education to colleagues and others
- Evidence of Mentoring and Coaching
- <u>PEDro Evidence-Based Physiotherapy Practice Level 3</u> (mandatory evidence, if no other scholar evidence provided) - must include reflection on learning and application to practice

PROFESSIONAL

Accepted supporting evidence includes:

- APA Cultural Safety Course: <u>Australian Physiotherapy Council's Cultural Safety Training for Physiotherapists</u> (mandatory evidence or provide evidence of equivalent)
- Cultural reflection evidenced in one of the OHP Case Studies
- Cross reference to Cultural Capability Reflection (Component II)
- Demonstrate a commitment to worker/client safety
- Demonstrate a commitment to workers/clients by applying best practice and high ethical standards
- Demonstrate commitment to the profession by adhering to relevant legislation, regulations and standards
